## AC Bebidas concludes Share acquisition in Peru

***Arca Continental now holds 99.78% of the shares with a right to vote of Corporación Lindley***

**Monterrey, Mexico. September 26, 2018.-** Arca Continental, S.A.B. de C.V., the second largest Coca-Cola bottler in Latin America, reports that its subsidiary, AC Bebidas, S. de R.L. de C.V informed the market that it has signed a stock purchase agreement with Peru Beverage Limitada S.R.L., a subsidiary of The Coca-Cola Company, through which AC Bebidas acquired 223,774,704 common shares of Corporación Lindley S.A., with voting rights, and representing 38.52% of the common shares which are unlisted in the Registro Público del Mercado de Valores de la Superintendencia del Mercado de Valores de Perú. As a result of the purchase of these shares, AC Bebidas holds 99.78% of the Corporacion Lindley voting shares to date.

AC Bebidas paid a total of US\$506,813,895 dollars to Peru Beverage Limitada for the purchase and transfer of the shares referred to above, which equates to US\$2.26 dollars per share.
