S&P Ratifies Credit Ratings of AC and AC Bebidas

- S&P confirms ratings for Arca Continental and AC Bebidas of mxAAA.

Monterrey, Mexico, March 31, 2020. – As a result of its operating strength and solid financial position to confront the impending operational challenges, Standard & Poor’s Global Ratings (S&P) affirmed the ratings for Arca Continental and AC Bebidas of “mxAAA” for issuer and subsidiary credit quality on a national scale, the highest national rating in Mexico, with a stable outlook.
