AC Bebidas Successfully Issues Local Green Bonds

- Bottler issues Ps. 4,650 million in Local Green Bonds; proceeds to fund sustainability projects.

Monterrey, Mexico, May 11, 2021.- Arca Continental, one of the world's largest Coca-Cola bottlers, announced today that its subsidiary AC Bebidas, S. de R. L. de C.V. ("AC Bebidas") successfully completed the issuance of Ps. 4,650 million in local green bonds ("*Certificados Bursátiles*").

The bonds are one of the first issued in pesos by a beverage company in Mexico. AC Bebidas placed two tranches, Ps. 3,000 million for 7 years accruing an annual fixed rate of 6.75% and Ps. 1,000 million for 4 years accruing a variable rate of TIIE plus 7 basis points.

The transaction was well received by investors, with an excess demand of 4.3 times of the amount issued.

Both issues received the highest credit ratings in Mexico, including "mxAAA" by S&P and "AAA(mex)" by Fitch Ratings.

"The fact that these bonds were so well received by investors is proof of the trust Arca Continental has built in the financial community, based on the positive financial results of the company during the pandemic, as a result of our discipline in managing debt and solid

The resources obtained from the placement will be used to finance green projects that promote the transition to a low carbon economy and comply with the Green Bond Principles (GBP) from the International Capital Market Association (ICMA) aligned to the Sustainable Development Goals of the United Nations.

Among the eligible projects are those that mitigate emissions from production activities, compensate water consumption, ecosystems and adjacent water bodies protection, and to reduce wastes and maximize recycling programs.

In this manner, Arca Continental ratifies its commitment to the environment and the harmonious development of the communities it serves, in a framework of ethics and social responsibility.
